# Instructions for Completing Comal County Water Oriented Recreation District Tax Return

<u>Who Must File</u> Every person, sole proprietorship, partnership, corporation, or other organization that is responsible for collection and/or payment of Comal County Water Oriented Recreation District (WORD) taxes must file a tax return. Lodging businesses using a third party to collect/remit tax must also file a return.

**Business Changes** It is your responsibility to notify the WORD office of any business changes or if you do not receive forms to report your taxes.

**<u>Returned Check Policy</u>** All returned checks will incur a \$25 fee regardless of the amount of the check or reason for the return.

## Due Date

Returns and payments must be received or postmarked on or before the 20<sup>th</sup> day of the month following each reporting period. **Returns must be filed for every period even if there is no amount subject to tax or no tax due.** Tax returns received after the due date with no postmark date will be considered late. If the due date falls on a weekend or legal holiday, the next business day will be the due date.

Tax Reporting Period	Due Date	Late Penalties and Fees
<b>First Quarter:</b> January 1 – March 31	April 20	<ul> <li>Flat late filing fee of \$25 assessed for ALL tax returns received or postmarked after the due date.</li> </ul>
Second Quarter: April 1 – June 30	July 20	<ul> <li>5% applies after the 20<sup>th</sup> day of the month following the tax reporting</li> </ul>
<b>Third Quarter:</b> July 1 – September 30	October 20	<ul> <li>period.</li> <li>10% after the 20<sup>th</sup> of the following month and permit is revoked.</li> </ul>
Fourth Quarter: October 1 – December 31	January 20	<ul> <li>Once permit is revoked, a \$250 reinstatement fee plus penalties and interest are due.</li> </ul>

<u>Total Taxable Sales</u> All taxable transactions under Section 324.099, Texas Local Government. **If you have no taxable sales to report, enter "0".** *Lodging* more than 30 days is exempt. *Equipment Rentals* under \$1.00 are exempt.



**Interest Calculations** Delinquent taxes and accrued penalties draw interest at the rate of 10% per year beginning 60 days after the date on which taxes were due.
